The New Mexico Annual Conference has partnered with **Protect My Ministry** to provide background checks and online child safety training at a discounted price. The discount price below is available to all our churches.

The Conference has contracted for the <u>Ministry Mobilizer Bundle #1</u>, \$149 cost to Local Church, which includes:



- 1. Background checks
- 2. Individual Online Child Safety Training
- 3. Automated Rescreening Notifications After One Year from Initial Screening
- 4. Online Tracking of Applicants

The applicant would submit a paper consent form to the church and the church enters the information online. Bundle #1 background checks will be billed directly to the church monthly. Extended services are offered to the churches through Ministry Mobilizer Bundles #2 and #3 at the election of the church and an additional cost to the church. These services are offered online either when you initially sign up with Protect My Ministry or later, but you are not required to choose an upgrade package. Background Checks

There are two tiers of background checks that we use. For churches in New Mexico the Basic Package can be used for low-risk volunteers who are not in a leadership position and will not be left alone with a child, youth or vulnerable adult. The Plus Package is used in New Mexico for all staff and volunteers who are in a leadership position. The Basic Package can be used in Texas for all staff and volunteers because the state of Texas shares all their county and state court information with the nationwide databases.

Basic Package: \$8.45

- National Criminal Database Search (includes Re-Verification of records)
- National Sex Offender Registry Search (includes alias and maiden names)
- SSN Verification and Address History Trace

Plus Package: \$17.00 (+fees if applicable) (CLM and Clergy-\$20.00)

- All the above + (1) Statewide or County Court Search

(Recommended in NM with a statewide criminal court search – no additional fees apply for New Mexico Statewide)

Individual Online Training

Protect My Ministry offers intuitive and interactive online training for volunteer and staff awareness of types of abuse, how to recognize abuse, and how to report and prevent abuse. The training is fully integrated with the Ministry Mobilizer package when the individual is entered into the system and the training can be completed from anywhere, 24/7. The training takes approximately 2 hours and does

not have to be completed in one session. You can start and stop when you want. The training is also available in Spanish.

OR

NMAC Certified Lay Ministers are trained to offer Basic Safe Sanctuaries in person or by ZOOM. Current information and signed certificate are provided.
